## Purpose of checklist

Proposed amendments to the City's Shoreline Master Program (SMP) are anticipated to be submitted to the Washington State Department of Ecology for agency review in spring 2025. Local adoption is anticipated in June 2025.

The City's shoreline jurisdiction can be seen on the Shorelines Map in SMP Appendix 1 and includes segments of these waterbodies, as well as lands extending 200 feet in all directions from the OWHM, FEMA floodways, and wetlands and river deltas associated with these waterbodies.
